**3. The specific purpose for which this corporation per Allentown Crime Watch President's Council By-laws shall be to standardize procedures, maintain quality and responsibility for the Crime Watch Program citywide. President's Council will also serve as a unified body with regard to major projects that would aid the Crime Watch program and any other Quality of Life issues**

***Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.***

**11. The membership of the President's Council of the Allentown Crime Watch shall be open to each Crime Watch group, Neighborhood Group and Associations that operates within the legal city limits of Allentown. The operating board of the President's Council of the Allentown Crime Watch shall comprise the individual President of each of these registered groups or a delegated representative and an additional representative as determined by each recognized group.**
